- a. PAN Card/ Passport/ Election ID Card of all the directors and shareholder.
- b. Latest Bank Statement
- c. Voter's ID/Driver's License/passport of all the directors and shareholders
- d. Passport-sized photographs of all directors and shareholder Copy of any Utility bill as a residential proof.In case of rented property a scan copy of Rent agreement along with NOC from the owner .

- a. Minimum number of 5 directors and 10 members should be there.
- b. Minimum paid-up capital of Rs. 5 Lakhs is required to form the company.
- c. Company can have as many as members they want as there is no maximum limit of the members.
- d.The Producer Company in India cannot be deemed as a public company.
- e. The former company can have only equity share capital.
- f. There should be at-least four boards meeting every year and the meetings should not be held less than once every three months.
